Subject: Alarming health-care situation in the Outaouais

Dear Minister,

On behalf of the Outaouais caucus, and with the united support of our colleagues from the National Capital Region, we write to you with deep concern regarding the healthcare situation in the Outaouais. Here are the main solutions proposed by healthcare experts in the Outaouais:

1. Bolster the wage premiums and enhance working conditions for healthcare personnel in the Outaouais. This initiative aims to not only retain existing staff but also attract new talent, countering the alarming trend of professionals leaving for opportunities in other provinces. By addressing this "hemorrhaging" of personnel,

we can stabilize the healthcare workforce and ensure consistent delivery of essential services to our communities.

- 2. Invest in the modernization of medical technology systems to facilitate information sharing between healthcare professionals, including those in Ontario and Quebec. This investment will enable quicker diagnoses, more informed treatment decisions, and ultimately, improved health outcomes for residents of the Outaouais.
- 3. Prioritize inter-regional equity in the allocation of healthcare resources and funding, so that the Outaouais receives its fair share. This approach promotes fairness and acknowledges the healthcare needs of our region, ultimately enhancing the overall well-being of our Quebecers.

We thank you for your attention to this urgent situation and look forward to your collaboration in ensuring that the necessary resources are allocated effectively and quickly to the Outaouais to meet the urgent needs of its citizens. We also hope that you will implement sustainable solutions to ensure equitable, quality access to healthcare for all Outaouais residents.
